## 1. General description

The 74ALVC541 is an 8-bit buffer/line driver with 3-state outputs. The device features two output enables ( $\overline{OE}1$  and  $\overline{OE}2$ ). A HIGH on  $\overline{OE}n$  causes the associated outputs to assume a high-impedance OFF-state.

Schmitt trigger action on all inputs makes the device tolerant of slow rise and fall times.

This device is fully specified for partial power down applications using  $I_{OFF}$ . The  $I_{OFF}$  circuitry disables the output, preventing the potentially damaging backflow current through the device when it is powered down.

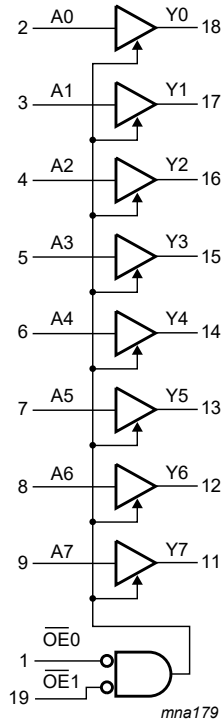


Fig. 1. Logic symbol

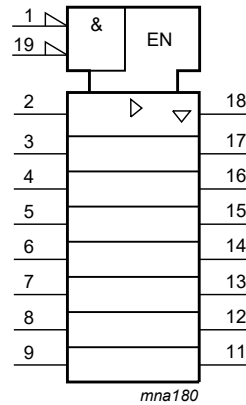
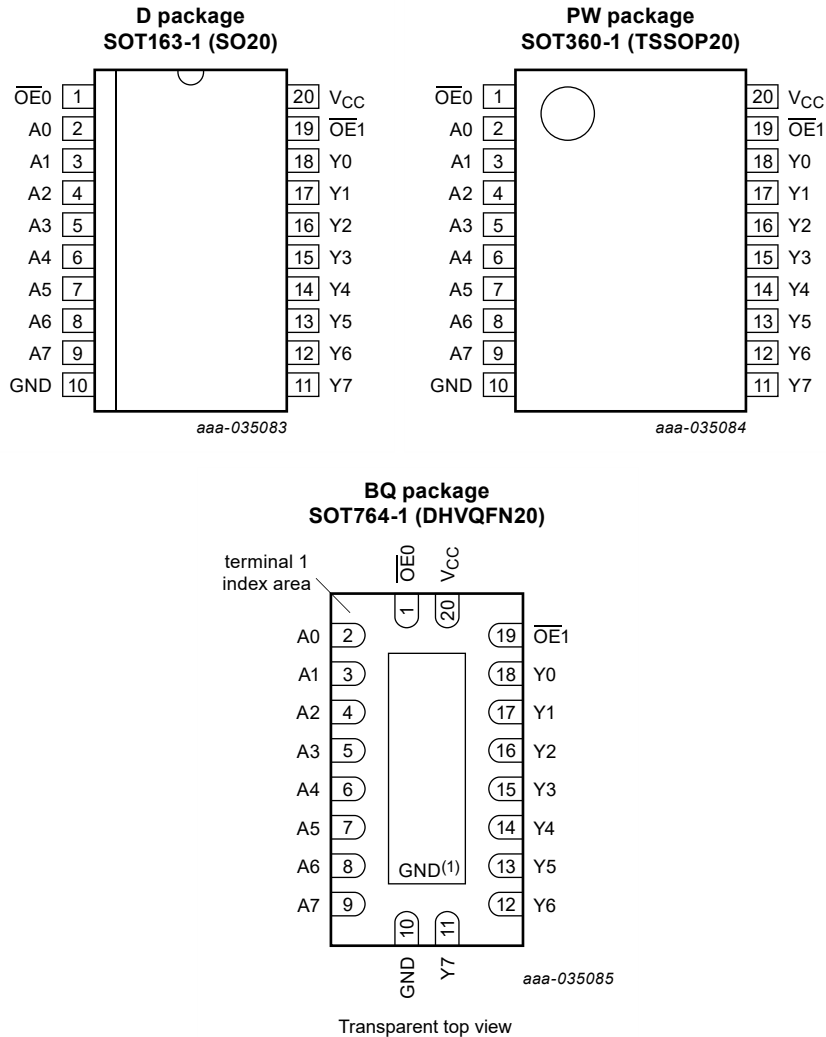


Fig. 2. IEC logic symbol

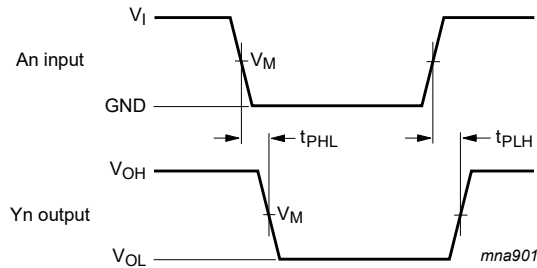

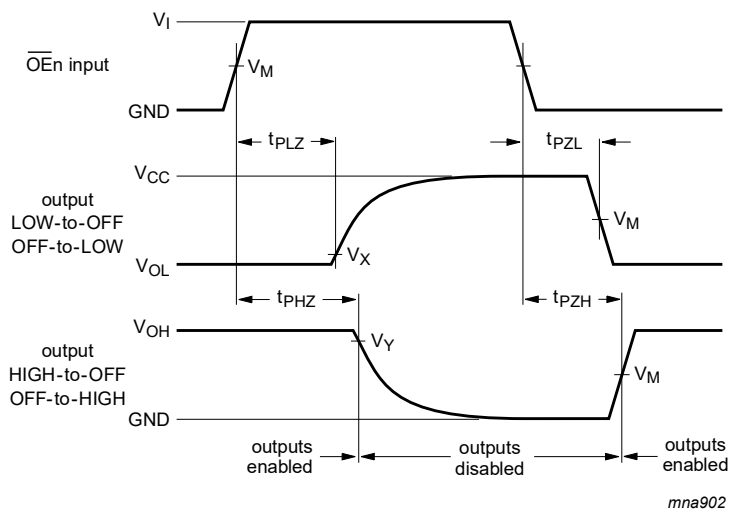

Fig. 3. Propagation delay input (An) to output (Yn)



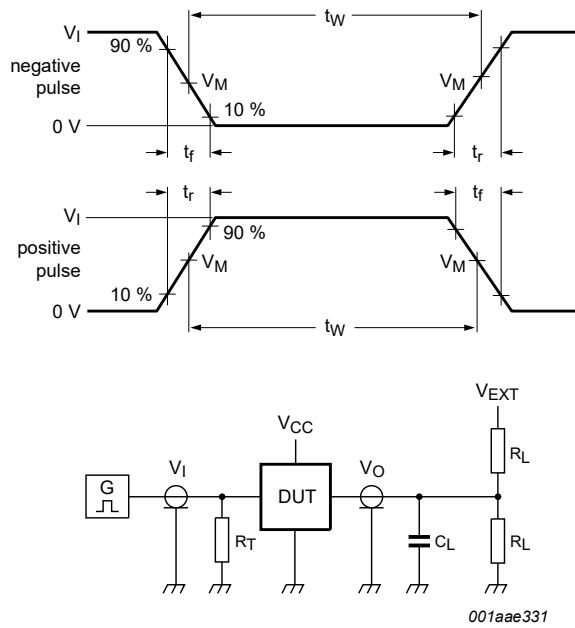

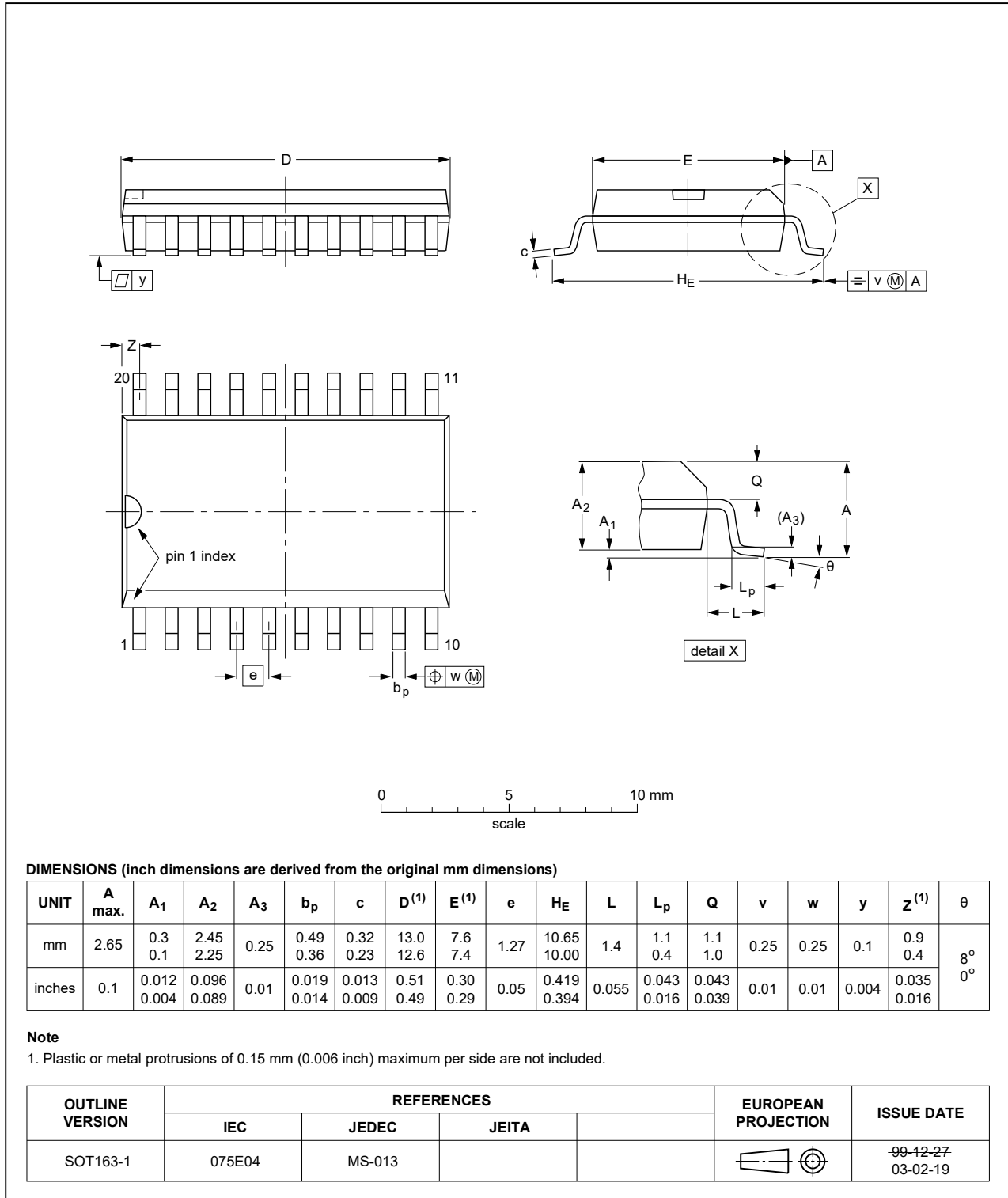


Fig. 6. Package outline SOT163-1 (SO20)

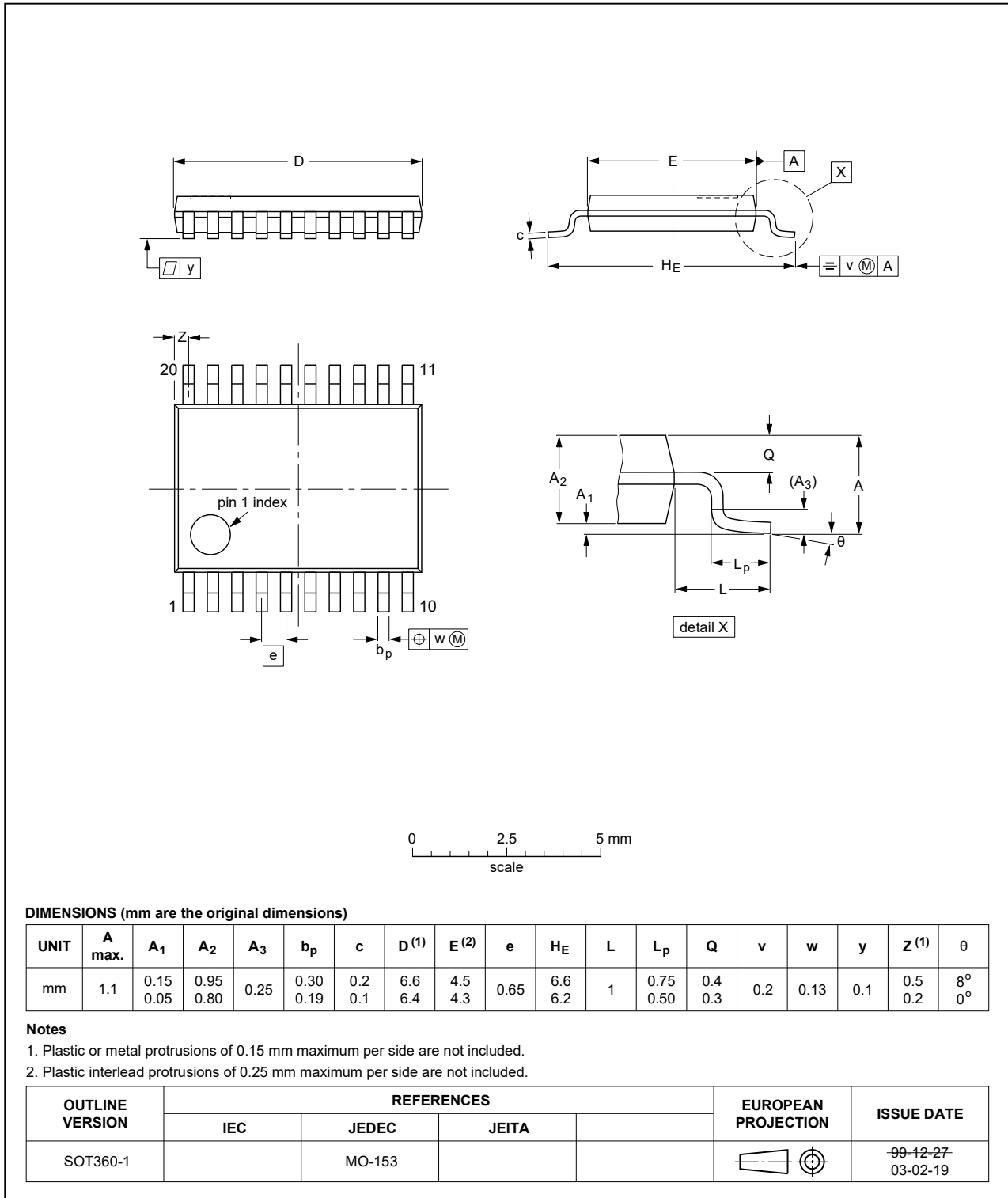


Fig. 7. Package outline SOT360-1 (TSSOP20)

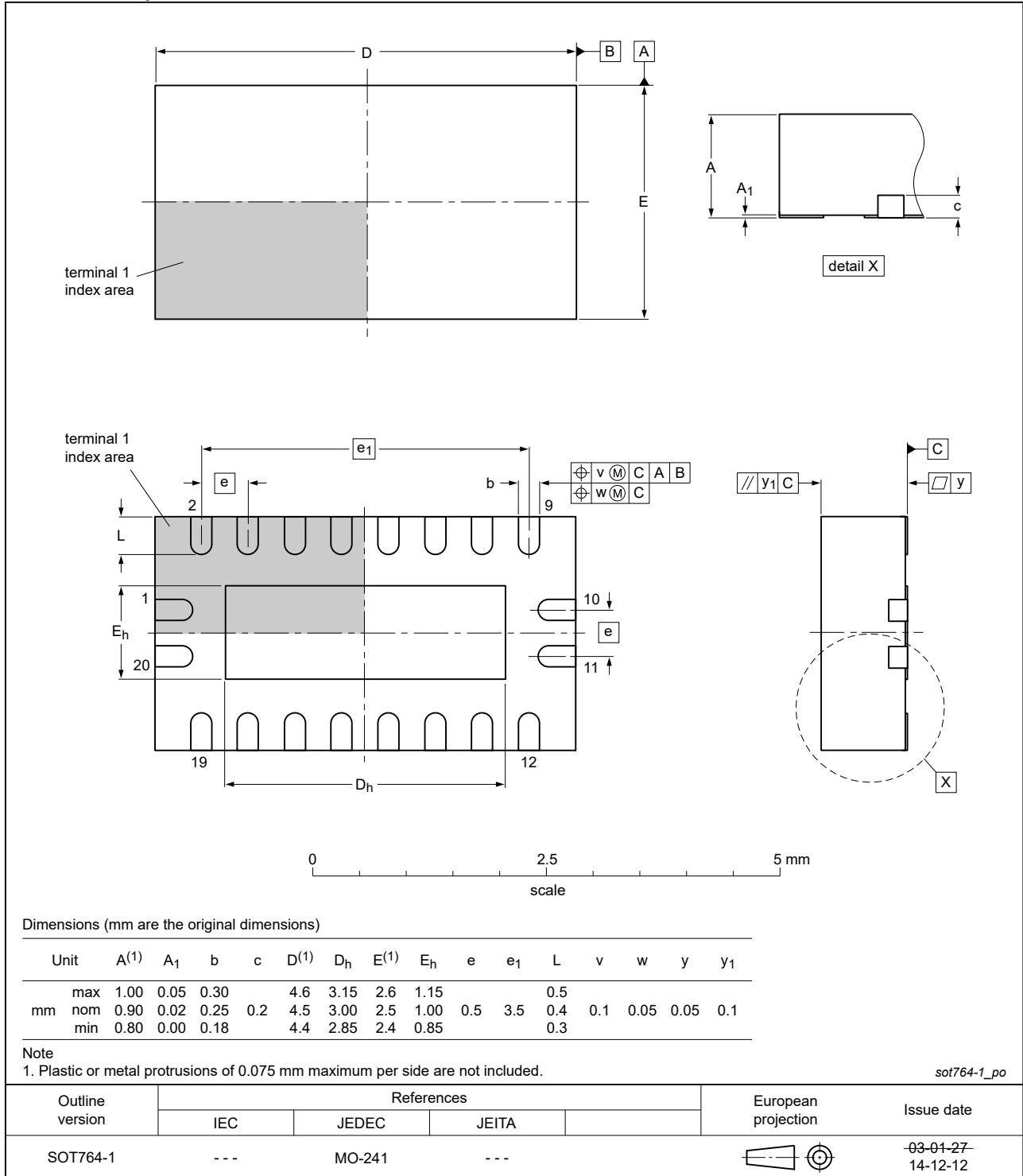


Fig. 8. Package outline SOT764-1 (DHVQFN20)
