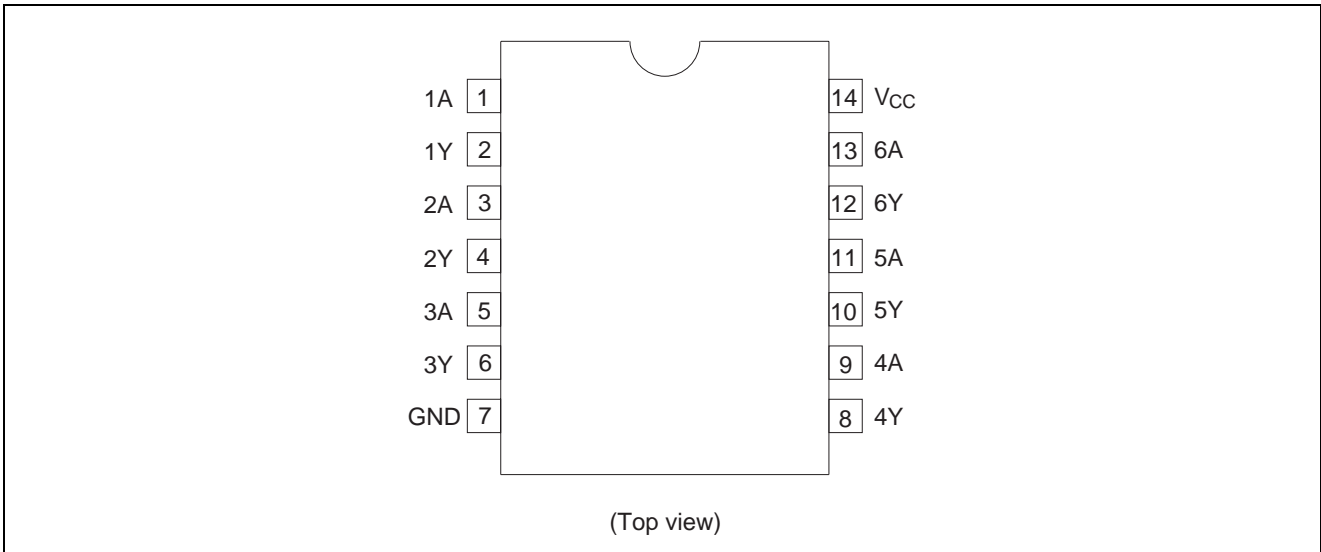

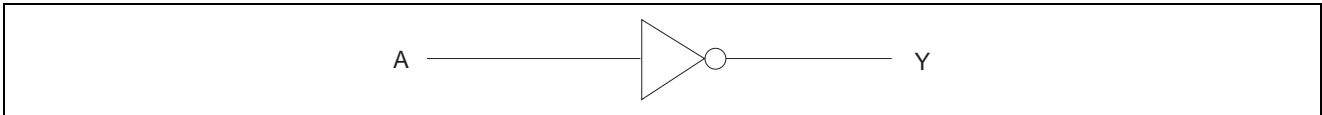

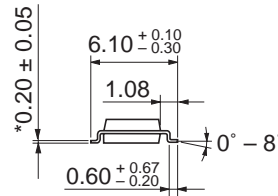
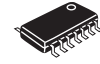
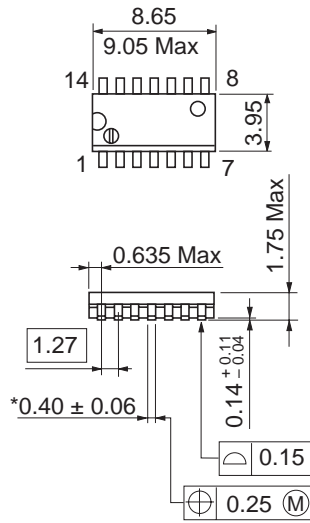


Package Dimensions

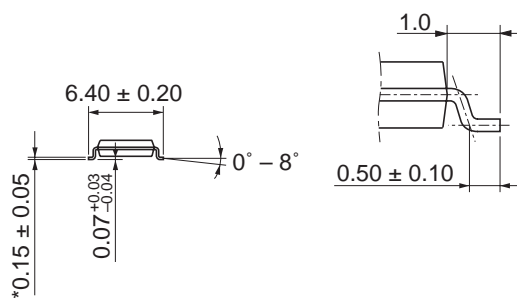
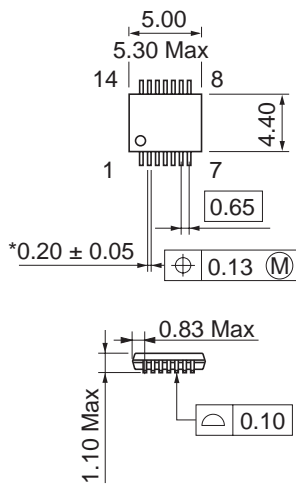
